The assistant public health authority (APHA) serves as back up to the public health authority (PHA) participating in community health activities and projects as assigned. Activities may include disease control, disease prevention and public health emergency involvement. Serving as a medical liaison for other agencies and medical facilities is also a part of the APHAs responsibilities. The APHA also works closely with the clinical team acting as a consultant, quality assurance team member, and author and reviewer of policy.
