**I. WELCOME**

The Alumni Association Past President, Dr. Brenda Moskovitz, called the Annual Alumni Association meeting to order at 12:44 p.m. Dr. Moskovitz welcomed alumni and guests.

**II. MIDTOWN DETROIT UPDATE**

Ms. Susan Mosey, the Executive Director MidTown Detroit, Inc. for 30 years is responsible for the community development, marketing, real estate, small business development and arts programming within the Detroit's University Cultural Center and New Center districts, which is the area known as the Midtown. MidTown Detroit, Inc. also manages public space maintenance and a number of programs including facade matching grant program and residential incentive programs.
